"Marine Touring" RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTIONS OF RISK, AND INDEMNITY AGREEMENT

WARNING-PLEASE READ CAREFULLY BEFORE SIGNING!

Consider that by signing this document you are assuming physical, financial, and legal risks and that you will waive certain legal rights, including the right to sue, which have potential financial implications for yourself and/or your family should you be injured, incapacitated, or killed while marine touring with Nootka Sound Service Ltd. Understand that marine environments do have inherent risks.

Assumption of Risks

I am aware and understand that marine touring exposes participants to many risks, dangers, and hazards, including, but not limited to; loss or damage to personal property; changing water flow, tides, currents, wave action, surf and ships wake which could cause capsizing; changes or variations in the weather that can greatly reduce visibility; cause collisions with other trip participants, the watercraft, other watercraft, and manmade or natural objects; immersion in cold water; hypothermia; drowning; changing weather conditions; sense of balance, physical condition, ability to swim and follow directions; falling objects; presence of marine life forms and wildlife; physical contact with wildlife; or suffering any type of injury or illness in areas without easy access to medical facilities; negligence on the part of other activity participants; and that some of the aforesaid risks are foreseeable, but others are not. While risks are inherent in the very nature of marine touring, others may result from **HUMAN ERROR AND NEGLIGENCE ON THE PART OF PERSONS INVOLVED. I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH MARINE TOURING AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PROPERTY DAMAGE, AND LOSS, PERSONAL INJURY OR DEATH RESULTING THEREFROM.**

RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND INDEMNITY AGREEMENT

- TO WAIVE ANY AND ALL CLAIMS that I have or may have against Nootka Sound Service Ltd, its representatives, members, directors, volunteers, and other affiliates, independent contractors, agents, successors, assigns (all of whom are hereinafter collectively referred to as "THE RELEASEES"), and to release THE RELEASEES from any and all liability for any loss, damage, expense or injury including DEATH that I may suffer, or that my next of kin may suffer resulting from any and all of my activities with Nootka Sound Service Ltd, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS, AND HAZARDS ASSOCIATED WITH MARINE TOURING, FROM Nootka Sound Service Ltd
